CLOSING COSTS FOR COOPERATIVES IN NEW YORK CITY

For many people the purchase or sale of an apartment will be one of the most significant financial transactions of their lives. In making a decision to purchase or sell, you should equip yourself with knowledge of the costs associated with the transaction. In order to help determine the asking price for a sale or the purchase price which a buyer may be able to afford, these expenses should be considered in advance. Listed below is general information regarding these transaction costs. The specific numbers may vary depending on the price of the property being conveyed or the building in which a sale or purchase is transacted. However, the information here should only be used as a guide, and for a more exact calculation of the costs, please contact our office and speak with an attorney. Federal	Foreign persons (and corporations) are required to have 10% of sale price withheld for Federal Tax.		
New York	Non-residents of New York must determine gain on sale and pay New York State income tax on any gain.
